Location: 204-06 Erie Street, Westmont, Johnstown, Cambria County, Pa.

<u>Description</u>: This rambling wood-framed house clad with horizontal wood with a multi-gabled roof and a large wrap-around porch is a two-and-a-half-story duplex that was originally a single-family home. There is elaborate ornamental detailing in the narrow pediment over the entrance to the porch and repeated above that on the second floor. The first-floor porch has a hipped roof which rests on turned, slender, bracketed columns and an enclosed railing covered with fishscale shingles. A small balcony at the second floor has turned posts supporting a shed roof.

History: Mary J. Cooper, a teacher, acquired this property from the Westmont Land and Improvement Company, Ltd., for \$780 on June 27, 1893. By 1895, a house was on her property that had an assessed value of \$2000. In 1904 Edwin S. Greer bought the undivided half of this property. In 1910, Cooper and Greer sold the house to Daniel Coolidge. The house and lots were assessed for \$3,800 in 1911.

Coolidge became president of Lorain Steel Company in the 1890s. Before moving to Westmont, he was living in Johnstown and had married a local girl, Lillian Rosensteel. He became a member of the prestigious Grove Bowling Club in 1897. Coolidge was originally from Philadelphia, and, according to Mrs. Barbara Rohrabaugh, the current owner of the property, Coolidge was President Calvin Coolidge's nephew. The Coolidges never had children. By 1913, they had added the whole western side of the house, making it a spacious place for entertainment. A ballroom was on the first floor of the addition.
